Brothers and Sisters of TWU Local 555,

In May and June, your Local Executive Board presided over District Membership meetings in the mega-stations in each of the respective districts. The purpose of the meetings was to deliver a State of Our Union address from President Randy Barnes, an updated account of the Local's financial affairs from Treasurer Jessica Hayes, and vote on proposed by-laws changes to our constitution. There was also an opportunity for members to submit their own agenda items, as well as a question, answer, and comment period for the members to address the Board.

The meetings were announced on the Local's website, mass-emails to the membership and postings to our social media and podcast platforms. In addition, emails were sent to members in each district and posted on social media prior to each meeting with the agenda, location, and rules for attending the meetings. To increase member turnout, this year we began offering the ability to attend the meeting virtually and many of you took advantage of that opportunity.

In the meetings, six articles in the by-laws were presented to the members for changes, with each member in attendance having the right to ask questions and comment about the changes before casting their vote. The votes have been counted and here are the results:




